FARMINGTON BOARD OF SELECTMEN

Tuesday, February 5, 2013

Chairman Stephan Bunker called the meeting to order at 6:30 P.M. with the following members present: Ryan Morgan, Andrew Hufnagel, Jessica Berry and Dennis Pike. Town Manager Richard Davis, Town Secretary Linda Grant, Treasurer Diana Young, Assessor Mark Caldwell, Police Chief Jack Peck, Parks and Recreation Director Steve Shible, Public Works Director Denis Castonguay, Budget Committee Chairman Joshua Bell, Channel 11, and members of the press and public were also in attendance.

ITEM 1: Pledge of Allegiance to the Flag

Ryan Morgan led those present in the Pledge of Allegiance to the Flag.

ITEM 2: To Review and Make Recommendations on the Following Proposed 2013 Departmental Budgets:

Stephan Bunker reported that, at the Budget Committee's final meeting on Wednesday, January 30, 2013 their recommendations mirrored all of the proposed budget requests except for the -0- recommendation for Safe Voices.

The consensus of the Board was to review and vote on each budget separately.

Dennis Pike moved to recommend the proposed amount of \$13,774 for the 2013 Franklin County Animal Shelter appropriation; Jessica Berry seconded.

At Andrew Hufnagel's request, Richard Davis explained the 35.50% increase in the appropriation request for Sandy River Recycling Association. He also reviewed changes that the Association has made, and plans to make, to reduce expenses. Mr. Hufnagel also generated a discussion regarding the possibility of a single sort operation.

Ryan Morgan moved to recommend the proposed amount of \$14,816 for the 2013 Sandy River Recycling Association appropriation; Andrew Hufnagel seconded.

VOTE AFFIRMATIVE 5 MOTION CARRIED

X) Outside Agencies

Andrew Hufnagel moved to recommend \$-0- funding for the 2013 American Red Cross appropriation; Ryan Morgan seconded.

The Selectman discussed why they were or were not in favor of funding this agency this year. Richard Davis stated, for the record, that he did not include an Article on the Town Meeting Warrant for the Farmington Downtown Association because the Association voted specifically to ask the Selectmen to refrain from doing so. Mr. Davis reviewed the American Red Cross request.

Andrew Hufnagel moved to recommend \$-0- funding for the 2013 Safe Voices appropriation; Ryan Morgan seconded.

Ryan Morgan pointed out that the Town received two letters from Safe Voices, one thanking the Town for the 2012 \$5,000 appropriation, and a second stating that they could not help the Town in regard to its request for a payment in lieu of taxes. Dennis Pike reminded the Board of the voters' overwhelming turnover of the Board and Budget Committee's -0- recommendation for the past two years.

Ryan Morgan moved to recommend the proposed amount of \$1,500 for the 2013 Shiretown Riders Snowmobile Club appropriation; Andrew Hufnagel seconded.

At Andrew Hufnagel and Dennis Pike's inquiry, Richard Davis explained the increase in the Club's request this year.

VOTE AFFIRMATIVE 4 OPPOSED 1 MOTION CARRIED (Ryan Morgan)

Andrew Hufnagel moved to recommend the proposed amount of \$1,000 for the 2013 Northern Lites and New Sharon Snow Riders Snowmobile Clubs appropriation; Jessica Berry seconded.

VOTE AFFIRMATIVE 5 MOTION CARRIED

Richard Davis stated that the Board of Selectmen has concurred with all of the Budget Committee's recommendations.

ITEM 3: To Determine the Method of Funding the Five Year Capital Improvement Program for Roads

Stephan Bunker reviewed the funding options, as presented and discussed at the January 22, 2013 Board of Selectmen's meeting. Mr. Bunker pointed out that ten of the twelve Budget Committee members present at their last meeting on January 30, 2013 voted unanimously to fund the program with the pay-as-you-go option. Mr. Bunker also stated that this Item will appear as a separate Article on the Town Meeting Warrant.

Dennis Pike moved to recommend the pay-as-you-go method of funding for the Five Year Capital Improvement Program for Roads; Jessica Berry seconded.

The Board discussed the recommended amounts to be requested each year, as well as the projected mill rate for this year. Chairman Joshua Bell was present and explained the Budget Committee's reasoning for its recommendation. Ryan Morgan pointed out that there are no frills in any of the 2013 budgets, so a reduction in any given department will result in loss of personnel, and ultimately a cut in that department's service(s).
