Mr. Davis stated the Town could potentially negotiate an agreement for NextEra Energy to provide electricity to the Recycling Facility. Joshua Bell asked what other solar companies are paying per acre. Richard Davis stated he will check with 2 -3 other solar companies and see what they have to offer.

The consensus of the Board of Selectmen was for Richard Davis to research fair market value for solar land lease in the area.

- B. Stephan Bunker asked if anyone planned on attending the 2019 Maine Municipal Association Convention on October 2 3<sup>rd</sup> at the Cross Insurance Center in Bangor. Michael Fogg stated he is interested in attending on October 3<sup>rd</sup>.
- C. Stephan Bunker opened discussion on the legislation to increase the number of Franklin County Commissioners and the districts they represent from three to five. If approved, it would take effect in 2022. Farmington would be divided into two districts, east and west of the Sandy River.
- D. Scott Landry asked when the Front Street project would be completed. Richard Davis stated that he believes the project will be completed next week.
