Fire fighters Patty Cormier and Stephan Bunker agreed to represent Farmington at the parade. Mr. Bunker encouraged everyone to watch the Rose Bowl Parade on television.
- D. Scott Landry stated that there was a sound quality issue with the sound system used at the Community Center during the Festival of Trees Christmas tree auction. Richard Davis stated that Matt Foster is working with Adrian Harris, and that the Rotary Club has offered to pay one third of the cost of a new sound system, with the Town paying one third using budgeted funds, and one third solicited from local benefactors who have helped in the past.
