### FARMINGTON BOARD OF SELECTMEN Tuesday, June 9, 2020

The meeting was conducted through remote access by telephonic, video, and electronic means. Chairman Joshua Bell called the meeting to order at 6:30 P.M. with the following members present: Stephan Bunker, Michael Fogg, Matthew Smith, and Scott Landry. Town Manager Richard Davis, Police Chief Jack Peck, Parks and Recreation Director Matthew Foster, Planning Assistant Cindy Gelinas, and the Mt. Blue TV camera operator were also physically in attendance.

Votes were taken by roll call.

#### ITEM 1: Pledge of Allegiance to the Flag

Chairman Joshua Bell led those present in the Pledge of Allegiance to the Flag.

### ITEM 4: To Consider Revising the Proposed 2020 Police and Parks & Recreation Department Budgets

Richard Davis reviewed the proposed 2020 Police budget in the amount of \$1,311,659, which is a decrease of \$88,123, or -6.295%. from the December 11, 2019 proposed budget. Police Chief Jack Peck stated that, due to issues beyond his control, the department was unable to fill two vacant patrol officer positions. The removal of the two patrol officer positions for six months reduces salary, FICA, and health insurance costs by \$58,546. Due to COVID-19 restrictions, the police academy closed, reducing training cost by \$9,350. COVID-19 also affected the price of motor fuel, decreasing projected fuel costs by \$7,000. Chief Peck reported that the department will not purchase a new police vehicle this year. The department will rely on the vehicles purchased through the State surplus program, which decreases the budget by \$20,000. Joshua Bell commended Chief Peck for the way he has run the department over the years. Mr. Bell stated that it speaks volumes that Chief Peck waited to hire the right candidates, never settling just to fill a position.

Stephan Bunker moved to recommend the proposed Police budget of \$1,311,659; Matthew Smith seconded.

Richard Davis reviewed the proposed 2020 Parks & Recreation/Community Center Building budget in the amount of \$325,558, which is an increase of \$11,931 over last year's budget, or

3.8%. Matthew Foster, Director of Parks and Recreation was present to answer the Selectmen's questions.

Mr. Davis stated that the proposed 2020 Town of Farmington budget in the amount of 6,114,616, is a decrease from 2019 of \$770, or -0.1%.

Stephan Bunker moved to recommend the proposed Parks and Recreation budget of \$325,558; Matthew Smith seconded.

A \$10,000 grant to create the sculpture was provided by the United Way of the Tri-Valley Area LEAP Explosion Fund. Scott Landry stated that Fire Rescue Chief Terry Bell and Diana Bell will meet with artist Vera Johnson and discuss design options for the LEAP Memorial Sculpture. Joshua Bell stated that once a final design is agreed upon, the placement of the sculpture should be discussed. The walkway to the sculpture should flow cohesively with current paths. Mr. Davis stated that he asked to be kept informed, and he will forward any information on to the Selectmen.

#### ITEM 6: To Accept the Resignation of Donna Tracy from the Planning Board

Richard Davis explained that after twenty-two years of service, Donna Tracy is stepping down from the Planning Board.

#### **ITEM 11:** To Discuss Other Business

**A.** Richard Davis stated that, on the original Town Meeting Warrant under Article 30, the Town set the interest on overdue real estate taxes at 9% and under Article 31, the Town set the interest to pay on refunds of overpaid or abated taxes at 5%. According to the Maine Municipal Tax Collectors' and Treasurers' Association (MMTCA), in January 2020, the State Treasurer's office mistakenly set the maximum interest rate at 9%. The maximum interest rate on overdue real estate taxes is actually 8%, and the minimum interest rate on refunds of overpaid or abated taxes can be set at 4.00%.

Matthew Smith moved to establish the interest rate on overdue real estate taxes at 8%; Scott Landry seconded.
