FARMINGTON BOARD OF SELECTMEN Tuesday, October 13, 2020

ITEM 2: To Hear an Update on the Planned Memorial Tribute for Bjorn Park

The following members of the memorial tribute committee were present: Vera's Iron and Vine owner Vera Johnson, artist John Nichols, artist Susie Sanders, and LEAP Executive Director Darryl Wood. John Nichols stated that the memorial will be 12 feet long by 10 feet high by 3 feet wide at the top. Mr. Nichols displayed a full color rendering of the proposed memorial. The roof, which sits on two posts, was designed to resemble an old fashioned fire station and offers an attractive cupola with an enclosed (non-working) bell. Nine bells, created from antique fire extinguishers, will hang from the eaves. Vera Johnson stated that the open rafter concept provides a space where folks can leave memorabilia (i.e. Fire Rescue Departments from Maine and around the country could staple FRD patches). Darryl Wood stated that, after much thought, the memorial was named, "Tribute to Resilience". In a time of tragedy we learned that with compassion, resilience, and strength a community can overcome anything. The memorial was designed to serve as a symbol of hope and healing. Stephan Bunker asked if the Bjorn, Bell, and Lord families supported the current design and location. Ms. Johnson stated that the families were involved in the design process and that she had lengthy discussions with Diana Bell and Chief Terry Bell.
